**Part A  
CONSENT OF LEGAL REPRESENTATIVE TO ENTERING AND PERFORMANCE OF SPORT ACTIVITIES**

Consent of the legal representative of minor under the age of 18 years for entering into and performance of sports activities in the sports areal HOP Arena, located at the address Obchodní 112, Čestlice Postal Code: 251 01 (the “sports areal”) operated by the company Trampoline Investments s.r.o., Company Id. No.: 018 20 877, with its registered office at Klimentská 1207/10, Nové město, 110 00 Prague 1, registered in the Commercial registry maintained with the Municipal Court in Prague under File No. C 211981 (the “Operator”).

*and I agree that my child (children) may enter the sports areal s and may take part in sports activities, provided that:*

- (a) if my child is **3 - 14 years of age**, he/she may enter the sports areal and may take part in sports activities **only under my constant supervision or under constant supervision of another person over 18 years of age**, and
- (b) if my child is **15 - 18 years of age**, he/she may enter the sports areal and may take part in sports activities **even without supervision of person over 18 years of age**.

**This consent is granted for an indefinite time period until my child reaches the age of majority or until withdrawal of this consent by child's legal representative.**

**By granting this consent I declare that:**

- I have got acquainted with General terms and conditions and Operating rules and necessity to obey them,
- both me and my child have seen the instructional video,
- my child is healthy and does not suffer from any illness or health issue which could negatively affect his/her health condition during taking part in sports activities.

**When granting this consent I am aware that:**

- during sports activities performed in the sports areal the serious injury to the child (e.g. fracture of the limb, concussion, head injury) or even injury resulting in death may occur,
- I am fully responsible for any and all harm suffered by the child in the sports areal and/or for any and all harm caused by the child to another person while performing sports activities,
- I am fully responsible for potential damage to the property of the Operator or to the property of other participants caused by breaching of the Operating rules by the child. In case that the child provably causes such damage I undertake to compensate such damage.

**I hereby declare that I instructed my child that:**

- it is necessary to obey the Operating rules,
- it is necessary to be cautious, considerate and pay attention to others,

the child is obliged to follow recommendations and orders of Operator's employees in charge of supervision (i.e. persons visibly marked by „HOP ARENA“ sign).

## **Part B CONSENT TO PROCESSING OF PERSONAL DATA**

I, the below undersigned declare that:

### **A. CONSENT**

I hereby agree that the company Trampoline Investments s.r.o., with its registered office at Klimentská 1207/10, Nové město, 110 00 Prague 1, registered in the Commercial registry maintained with the Municipal Court in Prague under File No. C 211981, Company Id. No.: 018 20 877 (the “Company“), in accordance with the Act No. 101/2000 Coll., on the Protection of Personal Data, as amended, as well with the regulation (EU) 2016/679 of the European Parliament and of the Council, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (the “GDPR“) may process my personal data as well as personal data regarding persons in relation to whom I exercise the parental responsibility.

### **B. WHICH PERSONAL DATA DOES THIS CONSENT CONCERN**

My consent concerns the below specified personal data, if such data have been provided to the Company by myself or by third person:

- (a) given name and surname
- (b) date of birth
- (c) address of permanent residence or other address
- (d) telephone number, e-mail address/addresses
- (e) birth number (as sensitive personal data)
- (f) passport/identity card number
- (g) marital status (as sensitive personal data)
- (h) sex
- (i) information concerning health status, in particular weight, height (as sensitive personal data)
- (j) biometric data, video recording from camera recording your body and movement in the sports areal, your signature (as sensitive personal data)
- (k) the above mentioned data concerning persons in relation to whom I exercise the parental responsibility

**C. FOR WHICH PURPOSES IS THIS CONSENT GRANTED**

My consent to the processing of my personal data is being granted for the purposes of performance of a contract, i.e. that I may use the sports facilities (trampolines and similar equipment) in the areal operated by the Company and also related services.

Furthermore the consent to the processing of my personal data is being granted for the purposes of protection of my vital interests i.e. ensuring the safety and protection of my life, health and property, as well as protection of life, health and property of other users of the sports areal and Company's property.

Furthermore the consent to the processing of my personal data is being granted for the purposes of Company's marketing - for sending offers of the Company or Company's business partners to me. I acknowledge that I may request the Company to provide me with the list of Company's partners which may contact me with marketing offers. I also grant this consent so that Company can create my profile for offering sales and other benefits to me.

If I grant this consent on behalf of a close person to whom I exercise the parental responsibility, I grant this consent to the processing of personal data of such close person and for the same purposes.

**D. THE PERIOD FOR WHICH IS THIS CONSENT GRANTED**

I grant this consent to the processing of my personal data as well as personal data of the close person to whom I exercise the parental responsibility for an indefinite time period.

**E. RIGHT TO WITHDRAW THE CONSENT**

I acknowledge that I have the right to withdraw this consent at any time. I acknowledge that even if I withdraw the consent the Company may process my personal data based on legal grounds stipulated by the GDPR. I acknowledge that processing of personal data during the time of validity of the consent shall be deemed as lawful even after the withdrawal of consent.

**F. SENSITIVE PERSONAL DATA**

I explicitly grant consent to the processing of my sensitive personal data, if such data have been provided to the Company by myself or by third person. I also explicitly grant consent to the processing of sensitive personal data of the close person to whom I exercise the parental responsibility if such data are provided to the Company by myself or by third person.

**G. TRANSFER OF PERSONAL DATA**

I agree that the Company may transfer my personal data and personal data of the close person to whom I exercise the parental responsibility to other entities if it is necessary for my usage

(or usage by persons close to me) of the sports facilities (trampolines and similar equipment) in the areal operated by the Company and also related services.

The Company shall not transfer the personal data to entities in other member states of the European Union or outside European Union.

**H. MEANS OF PROCESSING**

I agree that the personal data will be processed in electronic and material form. I acknowledge that the processing means any operation performed on my personal data.

**I. INFORMATION ON PROCESSING OF MY PERSONAL DATA**

I declare and confirm that prior to undersigning this consent I could get acquainted with the Company's *Information on processing of personal data* which describes how the Company processes personal data.
